# **Course Description:**

Introduces students to the process of research, including the ability to work from libraries, exhibitions and institutional archives, and developing skills in visual literacy and academic writing. Students are encouraged to develop independent thought by discovering, evaluating, and making appropriate use of a wide range of approaches to research and associated academic writing. Complementing the courses on theory, this course assists students with the identification of their own interests as they move towards choosing a thesis or professional research project.

## **Prerequisites:**

#### Aims and Objectives:

- To introduce students to the process of developing planning and conducting MA level autonomous research.
- To enable students to develop their visual literacy including sustained formal analysis
- To engage critically with both academic texts and primary sources.
- To consider the qualities of academic writing including effective arguments supporting evidence.
- To consider the ethical and safeguarding dimension of research, particularly as this applies in research dealing with human participants and community groups.
- To consider a range of different cultural approaches to research methods

• To examine and apply professional presentation skills

## **Teaching Methodology:**

Teaching will include interactive lectures, supplemented with a range of audiovisual aids, designed to introduce students to the key concepts of professional practice. Guest speakers

and activities will contribute alternative perspectives and experience. Students will develop their critical understanding of these concepts and their practical application through a range of workshops and group and individual exercises undertaken in class and out of class. Their group and individual presentations and written work will be discussed in feedback sessions which explore responses to issues arising from professional practice. The teaching will be supplemented with individual tutorials designed to address students' personal needs.
