Course Description:

The ways we see and understand a city inform the ways we react to its space and experience our lives. Artists, writers and architects continuously explore the boundaries between reality and imagination and make visible the creative spaces we inhabit. Through visits, individual and group projects and storytelling, students will take a series of spatial journeys as a means of exploring their own creative responses to urban reality, actively engaging with the visible and fictional landscapes of London.

- To introduce students to new ways of seeing London
- To provide students with specific historical and social perspectives in which to help them explore London's visible and fictional spaces
- To provide students with the information and skills necessary to critically assess key issues related to contemporary London's urban environment
- To facilitate students' exploration of London & enable them to develop their own creative responses to the city in which they are living
- To introduce students to the means by which they can monitor, build and reflect upon their personal development.
