Course Description:

Intended for students who have acquired graphic skills in drawing, illustration, and computer graphics or who have experience of photographic printing. It aims not so much to give indepth knowledge of particular printmaking processes as to stimulate a creative response to all areas of image making that involve printing. The course is practical in nature, although museum and gallery study, as well as some reading, is assigned relating to the techniques that are explored in class. A studio fee is levied on this course.

Prerequisites: ADM 4200 or ADM 4210 or ADM 5400 or ADM 5410

Aims and Objectives:

The course allows students to learn two different types of printing and encourages experimental exploitation of each printmaking process. The course is designed to highlight

the close relationship between theory and practice as a fundamental underpinning in enhancing creative approaches when generating new imagery. A sketchbook is used as evidence of, and to assist students with, the development of ideas and as a record of research/source material. These sketchbooks are presented with all project submissions

- In-depth understanding of Relief and Collagraphy printing techniques
- Critical and analytical approaches to making and interpreting prints
- Critical and analytical approaches in evaluating own work
- Use research and reference material to enhance creativity
- Accepted editioning practices
- Safe working practices

Assessment:

This course conforms to the Richmond University Special Programme Assessment Norms for Art, Design and Media approved by Academic Council on 28 June 2012.

Teaching Methodology:

The course is taught primarily through studio demonstration and is essentially a "hands-on" approach although students take notes to enable them to work independently. There are lectures on the theoretical, historical and technical aspects of printmaking processes. Students will also be directed to specific exhibitions that are relevant to the advancement of their own work. One class is taken in The Victoria and Albert Print Room.
