#### **Course Description:**

Engages students with current discourse on culture and education and how these are applied in performing arts organisations and public policy. The course then examines how the performing arts intersect formal (curriculum based), informal (parents, peer-group and the media) and non-formal (self-initiated creative forums including digital platforms) aspects of education. Students consider the role of performing arts in cultural adaptation, development of social conduct and political discourse through learning. Students examine case studies of the success and failure of the performing arts as instruments of urban renewal, both through capital projects and community engagement. As well as studying local and international contexts, the course will draw upon case examples of regional institutions in the UK.

# **Teaching Methodology:**

Teaching will include interactive lectures, supplemented with a range of audiovisual aids, designed to introduce students to the key concepts of professional practice. Guest speakers and activities will contribute alternative perspectives and experience. Students will develop their critical understanding of these concepts and their practical application through a range of workshops and group and individual exercises undertaken in class and out of class. Their

group and individual presentations and written work will be discussed in feedback sessions which explore responses to issues arising from professional practice. The teaching will be supplemented with individual tutorials designed to address students' personal needs.
