#### **Course Description:**

## Aims and Objectives:

The aim is to stimulate a sense of enquiry into the nature of visual communication within an art historical context and across cultural boundaries, thereby developing a questioning approach to ideas and possible preconceptions, and enabling a broader

appreciation of our common humanity.

Objectives of the course include the following:

- 1. understanding of the potential of the arts to communicate concepts and ideas.
- 2. understanding the practical implications of colour and illusory space within a communication context.
- 3. understanding of an historical and cultural context related to recent trends in art and design practice.
