**Course Description:** This course aims to introduce students to the contemporary performance scene in London – focusing upon music, dance, performance art, and installation art and fringe theatre. Themed in-class sessions will be supplemented by frequent field trips to performance venues in the London area. Students should budget for an additional £75 course fee for tickets to events.

# Aims and Objectives:

The course aims to:

- Explain the historical bases and rationale underlying a range of contemporary London-based performance practices
- Consider ways of understanding and appreciating a range of contemporary performance practices
- Introduce and discuss the history and development of a range of performancebased practices
- Discuss and develop a critical awareness of the ways in which contemporary performance practices are related to issues of cultural and sub-cultural identities

 Discuss and develop a critical awareness of the relationships between contemporary performance practices and broader socio-political process, such as cosmopolitanism, nationalism, environmental issues, changing patterns of urban employment, racism and sexism.
