Course Description:

Aimed primarily at students participating in the International Internship Programme, this course provides students with a comprehensive and detailed overview of contemporary British culture.

Prerequisites: None.

Aims and Objectives:

The aim of the course is to take students beyond the initial superficial aspects of "consumer" culture to reveal the elements that collectively can be considered as "British".

The course provides students with a comprehensive overview of contemporary British culture; an overview that engages with many aspects of current debate regarding national and cultural identity and questions how citizens interact with the modern state. The course will cover the historical processes that have helped shape UK society and now govern the social attitude and outlook of modern Britons. The course will also address issues that have become central to political and cultural reporting by the media. These will include differences between English, Scottish and Welsh identities; the role of Monarchy; UK Parliamentary Democracy; multiculturalism and religious faith in Britain.

In the context of British culture, the course will also focus on practical assistance to International Internship Programme students, to help them adapt to the context of "working-life". Student will be introduced to the social issues that are likely to influence the behaviour of their workplace colleagues.
