Course Description:

This is a foundations course comprised of a broad overview of information systems and technology, as principally used in support of business processes and decision-making activities. An in-depth discussion of the relationship, between organizations and information systems is a fundamental element of the course. Topics include: computer hardware and software, operating systems, the use of excel in management practice, social issues related to information systems. The use of excel provides a common thread in the topics covered throughout the course.

Aims and Objectives:

This course aims to familiarize the student with a wide range of features available in Microsoft's Excel spreadsheet software. The objective is to provide the student with skills across a suite of problems and analyses in business and economics such that possibly unrelated but similar problems may be readily solved in both academic and real-world settings. Wherever possible problems and analyses will be set so as to enhance and consolidate the mathematical and statistical skill of the student as well as providing additional exposure to topics being studied in other courses.

- Internal Rates of Return (I.R.R.) and Net Present Value (N.P.V).
- Using Solver and Goal Seek.
- Constrained optimization problems using Excel's Solver.
- Optimization applications in Business and Economics.
- Importing data in Comma Separated Variable format.
- Times series analysis.
- LOOKUPS, Charts and Text Analysis.

Teaching Methodology:

Typically, each new subject is introduced with a combination of background theory followed by instruction and demonstration of problem solutions via written notes in conjunction with a projected spreadsheet. Students are then expected to replicate the example with one-to-one assistance as necessary. Students then practice via similar examples in a tutorial setting. Reading may be set in advance of future new topics. Students are encouraged to work together where appropriate and in naturally formed groups. Course notes are provided for each subject and are available on the PowerCampus resource.
