Course Description:

Early start-up failure is not a rare occurrence in the world of entrepreneurship. Despite that, the chances of success are raised significantly with the right tools and skills set. Arming students with the knowledge of valuation of a start-up, analysing funding options and how to fail well, this course will prepare students to make knowledgeable decisions regarding the future of their start-up.
